# **BUSINESS FROM THE FLOOR**

Ms. Fries questioned the Township Ordinance regarding adjacent sidewalk maintenance. She resides on 24 Mile Road and her sidewalk is used by hundreds every day. To have her sidewalk replaced is costing \$300 and is very costly to her. She would like to have something proposed to change to have the sidewalks repaired and paid for.

Mr. Cowper stated the Township cannot pay for the replacement as do cities or villages. He asked Ms. Filarecki to explain that further.

Ms. Filarecki stated the Township does not own, operate or maintain any of the road ways. They do not get any tax dollars from the state or federal government. Cities and villages do receive funding based on mileage and ratings of their roads.

Ms. Fries asked how the homeowner approaches having this issue changed. Mr. Cowper suggested she attend a Board meeting and speak under "business from the floor".

Ms. Filarecki stated that she is still trying to obtain necessary easements for construction of the 2014 Master Project List.

The committee would need to decide if it would like to move forward with this.

Ms. Filarecki stated there are two places for funding. One is through MDOT which elects every quarter and the other is SEMCOG who elects only once a year and is guided through the southeast communities within the SEMCOG region.

Mr. Cowper questioned if it would be feasible for the Whitney Estates project to use the grant. Ms. Filarecki stated it has to be within a two mile radius to get to the school.

Ms. Filarecki stated the key component is achieving the school district involvement. This has been attempted in other communities and without the district support, it will not go forward.
