Mr. Wood met with Mr. Flynn to discuss payment option and processes for residents needing sidewalk repair.

Special cases will need to be reviewed by Township Engineer and reviewed by Sidewalk Committee, then recommend to the Township Board.

Mr. Wood will document processes and will present to the Sidewalk Committee for review
